Sub: APSCH –AC- CETs-2015 - Admission of students from outside the state of A.P into Category B Management Quota & Spot admissions under Convener Quota by SW-I Colleges and Management Quota/Convener Quota by SW-II and SW-III Colleges – Submission of lists for ratification of admissions by the Competent Authority – Imposing fine of Rs.5,000/- for each student admitted from outside the state of A.P – Reg.

The A.P State Council of Higher Education has been receiving lists of admissions into various courses made through various Common Entrance Tests held during 2015 for ratification by the Competent Authority. It is noticed that certain Managements have made admissions with candidates from outside the state of Andhra Pradesh, though the Council has issued notices to such colleges concerned / denied to ratify the admissions made in 2014-15 as there is no provision for such admissions in the rules in force. The Competent Authority noticed that such Managements have been approaching the Hon'ble High Court and obtaining interim orders for studies of such students.

In this background, the Competent Authority has decided to ratify the admissions made by the Colleges with students from states other than the state of AP (excluding the State of Telangana) by imposing a fine of Rs.5,000 on each student subject to submission of undertaking by the Management of Colleges concerned on the points as detailed hereunder :

- The Management made all efforts to fill up the seats with the students of AP and only made admissions with the students of other State by following transparency and merit.
- The Management shall submit to the Council, the antecedents of each student from the Station House Officer of the Police Station of the student area concerned in other State keeping in view the security of the State.
- The Management shall record the total details of each student in a separate register along with documentary proofs (like Voter card, Aadhar Card, driving license etc)

The Management of the Colleges are required to follow the above and remit the fine in the name of the College to the Account Number concerned through RTGS as indicated in the guidelines of the Council dt. 17.08.2015 and send details in the following format to the email ID concerned as specified in the said guidelines, by duly attaching the scanned copy of the counterfoil on which the name of the college has to be mentioned clearly.
